You are hereby invited to join the Nano Risk Governance task force, which is an action under the European NanoSafety Cluster, and attend the operational kick of meeting in Venice (Italy) on Wednesday, March 1, 2017. The meeting is conveniently organized as a side-arrangement to the Society for Risk Analysis Policy Forum Meeting on the Risk Governance for Key Enabling Technologies, which also takes place in Venice during this week.

Background

The EC wishes the nanosafety community to develop from focusing primarily on the issues around nanomaterials risk assessment to focus on the entire risk governance aspect for nanomaterials and nano-enabled products.

Nanotechnologies innovation can only succeed if all true and perceived risks are convincingly managed. The new technology must deliver higher benefits and, at the same time, lower risks than the technologies it replaces. The nanotechnologies research community must be ready today to respond to societal expectations of tomorrow regarding management of those risks.

Therefore, the EC has asked the nanosafety cluster to establish a document to define how we can operationalize nano-risk governance including the different topics and requirements and methods to establish and support an EC nano-risk governance body.

The EC action called "The EC Risk Governance Action" was launched on November 9, 2016 at the Nanosafety Cluster meeting in Grenoble in connection with the NANOSAFE 2016 conference and is coordinated by Keld Alstrup Jensen at the National Research Centre for the Working Environment (NRCWE), Denmark.

The deadline for the draft nanorisk governance document is December 20, 2017.





Workshop aims

- Aligning the nanosafety cluster participants on the topic of nanorisk governance
- Definition of the key elements / steps in risk governance, with initial discussions on their state-of-art in regards to content and future requirements
- Assign task leaders and teams to draft the descriptions of the key elements / steps in the nano-risk governance document
- Draft a work-plan towards completion of the risk governance document by December 20, 2017.
